

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Professional Services Contract between the Tohono O'odham Nation and Michael Brown, Esq.)

RESOLUTION NO. 18-415

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**
2 **the power "to employ legal counsel for the protection and advancement of the**
3 **Tohono O'odham Nation..." (Constitution, Article VI, Section 2(a)); and**

4 **WHEREAS, the increasing needs of tribal members for legal representation in criminal and**
5 **juvenile offender matters has caused a need for attorneys to handle cases where**
6 **the Tohono O'odham Advocate Program is ethically conflicted out of the**
7 **representation; and**

8 **WHEREAS, the Tohono O'odham Advocate Program prepared and submitted for review a**
9 **contract with Michael Brown to represent clients who cannot be represented by**
10 **the Nation's Advocate Program due to a conflict of interest; and**


11 **WHEREAS, the Domestic Affairs Committee has reviewed the contract and recommends**
12 **approval.**

13 **NOW, THEREFORE BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
14 **Professional Services Contract between the Tohono O'odham Nation and Michael**
15 **Brown Esq., in substantially the form attached hereto.**

16 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation Chairman is authorized to execute**
17 **the Professional Services Contract any amendments affecting the funds or**
18 **funding level shall be submitted for further approval by the Tohono O'odham**
19 **Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH**
21 **day of OCTOBER, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR;**
22 **-0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
23 **Article VI, Section 1 2(a) of the Constitution of the Tohono O'odham Nation, adopted by the**
24 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
26 **18, 1934 (48 Stat.984).**
