

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Enrollment Resolution Nos. 94-108, 96-382, and 01-495 to Correct
Names and/or Enrollment Numbers of Base Roll Additions)**

RESOLUTION NO. 18-429

1 **WHEREAS, Article II, Section 1(a) of the Constitution of the Tohono O'odham Nation**
2 **provides:**

3 **All Indians whose names appear on the official census rolls of the Sells and**
4 **Gila Bend Reservations as of January 1, 1937, and of the San Xavier**
5 **Reservation as of January 1, 1940, provided that additions and changes**
6 **may be made to said rolls by the Tohono O'odham Council, subject to the**
7 **approval of the Secretary of the Interior.; and**

8 **WHEREAS, the Nation's Enrollment Ordinance provides in part that:**

9 **The Enrollment Program shall submit the resolution and properly**
10 **formatted base roll document adding or changing the base roll to the**
11 **Secretary for approval. The Secretary will consider the Nation's request**
12 **and the statement in the resolution certifying that the additions were**
13 **properly researched in accordance with subsection C. (14 Tohono**
14 **O'odham Code Chapter 1, Article X, Section (4)(D)); and**

15 **WHEREAS, the Enrollment Program has identified a number of resolutions approving**
16 **members as base roll additions that misspelled or incorrectly listed the names of**
17 **members and/or incorrectly listed enrollment numbers; and**

18 **WHEREAS, the Enrollment Program therefore recommends that Resolution Nos. 94-108, 96-**
19 **382, and 01-495 be amended in part to reflect the correct name and/or enrollment**
20 **number for the members identified in the attached November 2018 Amending**
21 **Enrollment Resolution Summary, which is incorporated by this reference.**

22 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that Resolution**
23 **Nos. 94-108, 96-382, and 01-495 are amended upon the effective date of those**
24 **resolutions to reflect the correct name and/or enrollment number of base roll**
25 **additions for the members identified in the November 2018 Amending**
26 **Enrollment Resolution Summary.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH**
28 **day of NOVEMBER, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR;**
29 **-0- AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
30 **Article II, Sections 1 of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**
31 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
32 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**


