

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2019 Department of Public Safety Office of Emergency**  
**Management Budget Amendment No. 1)**

**RESOLUTION NO. 18-436**

1 **WHEREAS,** the Tohono O'odham Legislative Council is authorized "to manage any funds  
2 within the exclusive control of the Tohono O'odham Nation . . . and to appropriate  
3 these funds for the benefit of the nation and its members" provided that "[a]ll  
4 expenditures of these funds shall be pursuant to appropriations or budgets"  
5 authorized by resolution or ordinance (Constitution of the Tohono O'odham  
6 Nation, Article VI, Section 1(d)(2)); and

7 **WHEREAS,** the FY 2019 Department of Public Safety Office of Emergency Management Budget  
8 in the amount of \$630,974.45 was approved by Resolution No. 18-339; and

9 **WHEREAS,** the Department of Public Safety has prepared and submitted for review and  
10 approval its FY 2019 Office of Emergency Management Budget Amendment No. 1,  
11 which is incorporated by this reference and which will adjust operational and/or  
12 personnel items; and

13 **WHEREAS,** the FY 2019 Department of Public Safety Office of Emergency Management Budget  
14 Amendment No. 1 will increase the FY 2019 Department of Public Safety Office of  
15 Emergency Management Budget by \$198,870.00 from \$630,974.45 to \$829,844.45;  
16 and

17 **WHEREAS,** the Domestic Affairs and Budget and Finance Committees have reviewed the FY  
18 2019 Department of Public Safety Office of Emergency Management Budget  
19 Amendment No. 1 and recommend its approval.

20 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
21 **FY 2019 Department of Public Safety Office of Emergency Management Budget**  
22 **Amendment No. 1 effective October 1, 2018, which includes a \$198,870.00 increase**  
23 **from \$630,974.45 to \$829,844.45 that shall be funded by the Nation's general fund.**

24 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham  
25 Nation chairperson or any designated official is authorized to administer and  
26 expend the FY 2019 Department of Public Safety Office of Emergency  
27 Management Budget as amended, provided that any amendments or  
28 modifications shall be submitted for prior approval by the Tohono O'odham  
29 Legislative Council

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup>**  
31 **day of NOVEMBER, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR;**  
32 **-0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
33 **Article VI, Section 1 (d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**  
34 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
35 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
36 **18, 1934 (48 Stat.984).**






