

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Fee Land Purchase Budget)

RESOLUTION NO. 18-437

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2); and**

7 **WHEREAS, the FY 2018 Fee Land Purchase Budget in the amount of \$3,150,000.00 was**
8 **approved by Resolution No. 18-170, but as of September 30, 2018, the closing of**
9 **the land purchase has not been completed; and**

10 **WHEREAS, a budget has been prepared and submitted for review and approval for a FY 2019**
11 **Fee Land Purchase Budget for \$3,150,000.00, which is incorporated by this**
12 **reference and which carries over appropriated funding from FY 2018 approved**
13 **by Resolution No. 18-170; and**

14 **WHEREAS, the Economic Development Delegation, Commerce Committee, Budget and**
15 **Finance Committee, and Agricultural and Natural Resources Committees have**
16 **reviewed the FY 2019 Fee Land Purchase Budget and recommend its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
18 **FY 2019 Fee Land Purchase Budget for \$3,150,000.00, which shall be funded by the**
19 **Nation's general fund surplus carried over from FY 2018.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
21 **Nation chairperson and any designated official is authorized to administer and**
22 **expend the FY 2019 Fee Land Purchase Budget, provided however, that any**
23 **amendments or modifications shall be submitted for prior approval by the**
24 **Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05TH**
26 **day of NOVEMBER, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR;**
27 **-0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
28 **Article VI, Section 1 (d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
29 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat.984).**


