10		approval its FY 2019 Motor Pool Budget Amendment No. 1, which is incorporated						
11		by this reference and which will adjust operational line items; and						
12	WHEREAS,	the FY 2019 General Support Services Motor Pool Budget Amendment No. 1						
13		increases the total budget by \$120,000.00 from \$713,112.81 to \$833,112.81; and						
14	WHEREAS,	the Budget and Finance Committee has reviewed the FY 2019 General Support						
15		Services Motor Pool Budget Amendment No. 1 and recommends its approval.						
16	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odbam Legislative Council approves the							
17		FY 2019 General Support Services Motor Pool Budget Amendment No. 1 effective						
18		October 1, 2018, which includes a \$120,000.00 increase from \$713,112.81 to						
19		\$833,112.81 that shall be funded by the Nation's general fund.

21		Nation chairperson or any designated o fficial is authorized to administer and						
22		expend the FY 2019 General Support Services Motor Pool Budget as amended,

24		approval by the Tohono O'odham Legislative Council.
