

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 General Support Services Motor Pool Budget Amendment No. 1)**

RESOLUTION NO. 18-438

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2019 General Support Services Motor Pool Budget in the amount of**
8 **\$713,112.81 was approved by Resolution No. 18-339; and**

9 **WHEREAS, the General Support Services has prepared and submitted for review and**
10 **approval its FY 2019 Motor Pool Budget Amendment No. 1, which is incorporated**
11 **by this reference and which will adjust operational line items; and**

12 **WHEREAS, the FY 2019 General Support Services Motor Pool Budget Amendment No. 1**
13 **increases the total budget by \$120,000.00 from \$713,112.81 to \$833,112.81; and**

14 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2019 General Support**
15 **Services Motor Pool Budget Amendment No. 1 and recommends its approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
17 **FY 2019 General Support Services Motor Pool Budget Amendment No. 1 effective**
18 **October 1, 2018, which includes a \$120,000.00 increase from \$713,112.81 to**
19 **\$833,112.81 that shall be funded by the Nation's general fund.**

20 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
21 **Nation chairperson or any designated official is authorized to administer and**
22 **expend the FY 2019 General Support Services Motor Pool Budget as amended,**
23 **provided that any amendments or modifications shall be submitted for prior**
24 **approval by the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH**
26 **day of NOVEMBER, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR;**
27 **-0- AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
28 **Article VI, Section 1 (d)(2)and(3) of the Constitution of the Tohono O'odham Nation, adopted by**
29 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat.984).**
