

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Appointment of Mary Ann Ramirez as Executive
Director of the Gaming Office)

RESOLUTION NO. 18-441

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Nation's chairperson**
2 **with authority to appoint the Nation's treasurer, and other officers and heads of**
3 **all governmental departments with the approval of the Tohono O'odham**
4 **Legislative Council (Constitution, Article VII, Section 2(e)); and**

5 **WHEREAS, Chairman Edward Manuel has appointed Mary Ann Ramirez as the Executive**
6 **Director of the Gaming Office, subject to the approval of the Legislative Council;**
7 **and**

8 **WHEREAS, 1 T.O.C. Chapter 4 and 16 T.O.C. Chapter 1, Section 402, establish background**
9 **investigation, criminal history review, and other requirements for the**
10 **appointment of the Executive Director of the Gaming Office, and specifies that the**
11 **appointment must be approved by majority vote of the Legislative Council; and**

12 **WHEREAS, pursuant to Article III, Section 6(B) of the Legislative Rules of the Tohono**
13 **O'odham Legislative Council, the chairperson's "appointee to the position of**
14 **treasurer or other officers or heads of governmental departments shall not be**
15 **added to any Legislative Council session agenda for approval unless the**
16 **appropriate legislative committee interviews the appointee after receiving a**
17 **resume and written background investigation report" containing detailed**
18 **employment, education, credit, litigation, and other information necessary to**
19 **determine the appointee's qualifications and fitness; and**

20 **WHEREAS, the Legislative Commerce Committee has received and reviewed the detailed**
21 **written background investigation report required by the Legislative Rules, 16**
22 **T.O.C. Chapter 1, Section 402, and 1 T.O.C. Chapter 4, interviewed the appointee,**
23 **and recommends that the Legislative Council approve the appointment.**

24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
25 **appointment of Mary Ann Ramirez as Executive Director of the Gaming Office.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH**
27 **day of NOVEMBER, 2018 at a meeting at which a quorum was present with a vote of 2,348.4 FOR;**
28 **736.2 AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council**
29 **by Article VII, Section 2 (e) of the Constitution of the Tohono O'odham Nation, adopted by the**
30 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
32 **18, 1934 (48 Stat.984).**
