

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2019 San Lucy District Budget)**

**RESOLUTION NO. 18-442**

1 **WHEREAS, pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham**  
2 **Nation,**

3 **No district council shall expend district funds except pursuant to budgets**  
4 **authorized under resolutions of the district council and approved by the**  
5 **Tohono O'odham Council. The management of these funds shall be only**  
6 **by a treasurer or other authorized officer of the district council who has**  
7 **furnished a surety bond satisfactory to the treasurer of the Tohono**  
8 **O'odham Nation, and all expenditures of these funds shall be by checks**  
9 **signed by such treasurer or other authorized officer and the chairman or**  
10 **vice-chairman of the district council**

11 **; and**

12 **WHEREAS, by San Lucy District Council Resolution No. SL 11-203-18, the San Lucy District has**  
13 **authorized the FY 2019 San Lucy District Budget, which is incorporated by this**  
14 **reference in the amount of \$7,484,754.68; and**

15 **WHEREAS, the Budget and Finance Committee has reviewed the FY 2019 San Lucy District**  
16 **Budget and recommends its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
18 **FY 2019 San Lucy District Budget in the amount of \$7,484,754.68, which includes**  
19 **funding from:**

- 20 **(1) FY 2019 Gaming Allocation - Equal in the amount of \$3,273,977.01;**  
21 **(2) FY 2019 Gaming Allocation - Host Share in the amount of \$3,726,708.44;**  
22 **(3) FY 2019 Mining Allocation - Asarco in the amount of \$372,121.10; and**  
23 **(4) FY 2019 Mining Allocation - Cyprus in the amount of \$111,948.13.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the FY 2019 San Lucy**  
25 **District Budget shall be managed and expended in accordance with Article IX,**  
26 **Section 7 of the Constitution of the Tohono O'odham Nation and the Nation's laws,**  
27 **provided that any amendments or modifications shall be authorized under**  
28 **District Council resolution and submitted for prior approval by the Tohono**  
29 **O'odham Legislative Council.**

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup>**  
31 **day of NOVEMBER, 2018 at a meeting at which a quorum was present with a vote of 1,841.7 FOR;**  
32 **1.007.1 AGAINST; 235.8[02] NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the**  
33 **Council by Article IX, Section 7 of the Constitution of the Tohono O'odham Nation, adopted by**  
34 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
35 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
36 **18, 1934 (48 Stat.984).**
