

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving November 2018 Legislative Rules Amendments)**

**LEGISLATIVE ORDER NO. 18-449**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Tohono O'odham**  
2 **Legislative Council with the power to establish rules and procedures to regulate**  
3 **all meetings of the Council and its standing committees (Constitution of the**  
4 **Tohono O'odham Nation, Article VI, Section 1(a)); and**

5 **WHEREAS, the Legislative Council has exercised this power by adopting and amending the**  
6 **Legislative Rules of the Tohono O'odham Legislative Council ("Legislative Rules");**  
7 **and**

8 **WHEREAS, the Legislative Rules Committee recommends that the Legislative Council amend**  
9 **Legislative Rules Article IX, Section (B) in accordance with the attached**  
10 **Legislative Rules amendments dated for reference November 2018, which**  
11 **amends the process of presenting legislation to Chairperson of the Nation.**

12 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council adopts the**  
13 **Legislative Rules amendments as dated for reference November 2018 to amend**  
14 **the process of presenting legislation to Chairperson of the Nation.**

15 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup> day of**  
16 **NOVEMBER, 2018 at a meeting at which a quorum was present with a vote of 2,875.6 FOR; -0-**  
17 **AGAINST; [01] NOT VOTING; and 209.0 [05] ABSENT, pursuant to the powers vested in the Council**  
18 **by Article VI, Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the**  
19 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
20 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
21 **18, 1934 (48 Stat.984).**
