

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2019 Veterans Affairs Office Donations and Contributions  
Budget Amendment No. 1)**

**RESOLUTION NO. 18-463**

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**  
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**  
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**  
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**  
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**  
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2019 Veterans Affairs Office Donations and Contributions Budget in the**  
8 **amount of \$67,883.58 was approved by Resolution No. 18-359; and**

9 **WHEREAS, the Veterans Affairs Office has prepared and submitted for review and approval**  
10 **its FY 2019 Donations and Contributions Budget Amendment No. 1, which is**  
11 **incorporated by this reference and which will adjust operational and/or**  
12 **personnel line items; and**

13 **WHEREAS, the FY 2019 Veterans Affairs Office Donations and Contributions Budget**  
14 **Amendment No. 1 will increase the FY 2019 Veterans Affairs Office Donations and**  
15 **Contributions Budget by \$500.00 from \$67,883.58 to \$68,383.58; and**

16 **WHEREAS, the Human Resources Development and Budget and Finance Committees have**  
17 **reviewed the FY 2019 Veterans Affairs Office Donations and Contributions Budget**  
18 **Amendment No. 1 and recommend its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
20 **FY 2019 Veterans Affairs Office Donations and Contributions Budget Amendment**  
21 **No. 1, which includes a \$500.00 increase from \$67,883.58 to \$68,383.58, that shall**  
22 **be funded by revenue donations.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
24 **Nation chairperson or any designated official is authorized to administer and**  
25 **expend the FY 2019 Veterans Affairs Office Donations and Contributions Budget**  
26 **as amended, provided however, that any amendments or modifications shall be**  
27 **submitted for prior approval by the Tohono O'odham Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 03<sup>RD</sup>**  
29 **day of DECEMBER, 2018 at a meeting at which a quorum was present with a vote of 2,858.7 FOR;**  
30 **-0- AGAINST; -0- NOT VOTING; and 225.9[05] ABSENT, pursuant to the powers vested in the**  
31 **Council by Article VI, Section 1 (d)(2)and(3) of the Constitution of the Tohono O'odham Nation,**  
32 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**  
33 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**  
34 **Act of June 18, 1934 (48 Stat.984).**
