

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Department of Health and Human Services Division of
Senior Services Budget Amendment No. 1)

RESOLUTION NO. 18-466

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2019 Department of Health and Human Services Division of Senior Services**
8 **Budget in the amount of \$723,741.00 was approved by Resolution No. 18-339; and**

9 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**
10 **review and approval its FY 2019 Division of Senior Services Budget Amendment**
11 **No. 1, which is incorporated by this reference and which will adjust personnel**
12 **and/or operational line items and created new line items; and**

13 **WHEREAS, the FY 2019 Department of Health and Human Services Division of Senior Services**
14 **Budget Amendment No. 1 will not change the total budget amount of \$723,741.00;**
15 **and**

16 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
17 **reviewed the FY 2019 Department of Health and Human Services Division of**
18 **Senior Services Budget Amendment No. 1 and recommend its approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **FY 2019 Department of Health and Human Services Division of Senior Services**
21 **Budget Amendment No.1 effective October 1, 2018, which does not change the**
22 **total budget amount of \$723,741.00 and which will create new line items.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
24 **Nation chairperson or any designated official is authorized to administer and**
25 **expend the FY 2019 Department of Health and Human Services Division of Senior**
26 **Services Budget as amended, provided however, that any amendments or**
27 **modifications shall be submitted for prior approval by the Tohono O'odham**
28 **Legislative Council.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH**
30 **day of DECEMBER, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR;**
31 **-0- AGAINST; -0- NOT VOTING; and [08] ABSENT, pursuant to the powers vested in the Council by**
32 **Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation, adopted by**
33 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
34 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
35 **18, 1934 (48 Stat.984).**
