

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2019 Department of Health and Human Services Management of
Health Budget Amendment No. 1)**

RESOLUTION NO. 18-467

1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation . . . and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the FY 2019 Department of Health and Human Services Management of Health**
8 **Budget in the amount of \$1,651,350.00 was approved by Resolution No. 18-340;**
9 **and**

10 **WHEREAS, the Department of Health and Human Services has prepared and submitted for**
11 **review and approval its FY 2019 Management of Health Budget Amendment No. 1,**
12 **which is incorporated by this reference and which will adjust personnel and/or**
13 **operational line items; and**

14 **WHEREAS, the FY 2019 Department of Health and Human Services Management of Health**
15 **Budget Amendment No. 1 will not change the total budget amount of**
16 **\$1,651,350.00; and**

17 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
18 **reviewed the FY 2019 Department of Health and Human Services Management of**
19 **Health Budget Amendment No. 1 and recommend its approval.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
21 **FY 2019 Department of Health and Human Services Management of Health**
22 **Budget Amendment No. 1 effective October 1, 2018, which will not change the total**
23 **budget amount of \$1,651,350.00.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
25 **Nation chairperson or any designated official is authorized to administer and**
26 **expend the FY 2019 Department of Health and Human Services Management of**
27 **Health Budget as amended, provided that any amendments or modifications**
28 **shall be submitted for prior approval by the Tohono O'odham Legislative Council.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH**
30 **day of DECEMBER, 2018 at a meeting at which a quorum was present with a vote of 2,827.7 FOR;**
31 **-0- AGAINST; -0- NOT VOTING; and 256.9 [08] ABSENT, pursuant to the powers vested in the**
32 **Council by Article VI, Section 1(d)(2) and (3) of the Constitution of the Tohono O'odham Nation,**
33 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
34 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
35 **Act of June 18, 1934 (48 Stat.984).**
