

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2019 San Xavier District Budget Amendment No. 1)**

**RESOLUTION NO. 18-477**

1 **WHEREAS,** pursuant to Article IX, Section 7 of the Constitution of the Tohono O'odham  
2 Nation,

3 No district council shall expend district funds except pursuant to budgets  
4 authorized under resolutions of the district council and approved by the  
5 Tohono O'odham Council. The management of these funds shall be only by  
6 a treasurer or other authorized officer of the district council who has  
7 furnished a surety bond satisfactory to the treasurer of the Tohono  
8 O'odham Nation, and all expenditures of these funds shall be by checks  
9 signed by such treasurer or other authorized officer and the chairman or  
10 vice chairman of the district council.

12 **WHEREAS,** the FY 2019 San Xavier District Budget in the amount of \$13,331,452.00 was  
13 authorized by the San Xavier District Council Resolution No. SXDC 08-18-06 and  
14 approved by Legislative Council Resolution No. 18-391; and

15 **WHEREAS,** by San Xavier District Council Resolution No. SXDC 11-18-02, the San Xavier  
16 District has authorized and submitted for review and approval its FY 2019 San  
17 Xavier District Budget Amendment No. 1, which is incorporated by this reference  
18 and which will adjust operational and/or personnel line items; and

19 **WHEREAS,** the FY 2019 San Xavier District Budget Amendment No. 1 will increase the FY 2019  
20 San Xavier District Budget by \$276,974.79 from \$13,331,452.00 to \$13,608,426.79;  
21 and

22 **WHEREAS,** the Budget and Finance Committee has reviewed the FY 2019 San Xavier District  
23 Budget Amendment No. 1 and recommends its approval.

24 **NOW, THEREFORE, BE IT RESOLVED** that the Tohono O'odham Legislative Council approves the  
25 FY 2019 San Xavier District Budget Amendment No. 1, which includes a  
26 \$276,974.79 increase from \$13,331,452.00 to \$13,608,426.79.

27 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the FY 2019 San  
28 Xavier District Budget as amended shall be managed and expended in  
29 accordance with Article IX, Section 7 of the Constitution of the Tohono O'odham  
30 Nation and the Nation's laws, provided that any amendments or modifications  
31 shall be authorized under District Council resolution and submitted for prior  
32 approval by the Tohono O'odham Legislative Council.
