

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the FY 2019 Professional Services Agreement Between the Tohono  
O'odham Nation and Tucson Unified School District Community Education Programs)**

**RESOLUTION NO. 18-488**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with**  
2 **the power "to consult, negotiate and conclude agreements and contracts on**  
3 **behalf of the Tohono O'odham Nation with Federal, State and local governments**  
4 **and other Indian tribes or their departments, agencies, or political subdivisions,**  
5 **or with private persons or organizations on all matters within the authority of the**  
6 **Tohono O'odham Council." (Constitution, Article VI, Section 1(f)); and**

7 **WHEREAS, the Tohono O'odham Nation provides services to improve the availability,**  
8 **affordability, and quality of child care for members of the Nation; and**

9 **WHEREAS, the Tohono O'odham Nation's Child Care Program wishes to enter into a**  
10 **Professional Services Agreement with Tucson Unified School District Community**  
11 **Education Programs to provide child care services for the Nation's children who**  
12 **are eligible to receive child care services; and**

13 **WHEREAS, the FY 2019 Professional Services Agreement has been reviewed by the Human**  
14 **Resources Development Committee which recommends its approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**  
16 **FY 2019 Professional Services Agreement between the Tohono O'odham Nation**  
17 **and Tucson Unified School District Community Education Programs**  
18 **substantially in the form attached and authorizes the Nation's Chairman to**  
19 **execute it.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup>**  
21 **day of DECEMBER, 2018 at a meeting at which a quorum was present with a vote of 3,084.6 FOR;**  
22 **-0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
23 **Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
24 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**  
26 **(48 Stat.984).**




