1 **WHEREAS, the Tohono O'odham Legislative Council is authorized "to manage any funds**
2 **within the exclusive control of the Tohono O'odham Nation...and to appropriate**
3 **these funds for the benefit of the nation and its members" provided that "[a]ll**
4 **expenditures of these funds shall be pursuant to appropriations or budgets"**
5 **authorized by resolution or ordinance (Constitution of the Tohono O'odham**
6 **Nation, Article VI, Section 1(d)(2)); and**

7 **WHEREAS, the Department of Health and Human Services HIV/AIDS Disease Intervention**
8 **Surveillance Program has prepared and submitted for review and approval its FY**
9 **2019 Enhancing HIV/AIDS Screening and Patient Navigation Project Grant**
10 **Budget, which is incorporated by this reference, in the amount of \$35,477.50 to be**
11 **funded by the Nation's general fund pending reimbursement from the grantor;**

13 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
14 **reviewed the FY 2019 Department of Health and Human Services HIV/AIDS**
15 **Disease Intervention Surveillance Program Enhancing HIV/AIDS Screening and**
16 **Patient Navigation Project Grant Budget and recommend its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
18 **FY 2019 Department of Health and Human Services HIV/AIDS Disease**
19 **Intervention Surveillance Program Enhancing HIV/AIDS Screening and Patient**
20 **Navigation Project Grant Budget effective October 1, 2018 in the amount of**
21 **\$35,477.50, which shall be funded by the Nation's general fund pending**
22 **reimbursement from the grantor.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
24 **Nation chairperson or any designated official is authorized to administer and**
25 **expend the FY 2019 Department of Health and Human Services HIV/AIDS Disease**
26 **Intervention Surveillance Program Enhancing HIV/AIDS Screening and Patient**
27 **Navigation Project Grant Budget, provided that any amendments or**
28 **modifications shall be submitted for prior approval by the Tohono O'odham**


