

13 **171.8 AGAINST; 104.8 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the**  
14 **Council by Article II, Section 3 and Article IV, Section 1 (h) of the Constitution of the Tohono**  
15 **O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved**  
16 **by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**  
17 **pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
