(Accepting Certification of Eligible Members and Authorizing the Initial Expenditure of Funds for Per Capita Payments under the Initiative)

RESOLUTION NO. 2000-005

1	WHEREAS,	on June 28, 1997 the voters of the Tohono O'odham Nation (the "Nation") approved
2		Initiative No. IN-01-97 (the "Initiative"); and
3	WHEREAS,	the Initiative authorized funding from Gaming Revenues for several measures,
4		including a one-time per capita distribution of \$2,000 to each member of the
5		Nation enrolled on June 28, 1997 (the "Initial Per Capita Distribution"); and
6	WHEREAS,	pursuant to Resolution 97-451, the Legislative Council adopted an Initiative
7		Funding and Implementation Plan (the "FIP") which authorized the
8		establishment of set-aside accounts for the Initial Per Capita Distribution and
9		other Initiative measures, and set certain conditions on the expenditure of funds
10		from such accounts; and
11	WHEREAS,	by Resolution 97-478, the Legislative Council approved the transfer of funds from
12		the Desert Diamond Savings Account to certain designated set-aside accounts
13		established at Bank of America Arizona, including the sum of \$41.5 million to set-
14		aside account no. 3030425-1067524 for the Initial Per Capita Distribution (the "Per
15		Capita Account"); and
16	WHEREAS,	three of the conditions to expenditure of the Per Capita Account specified in the
17		FIP are (1) approval by the Secretary of the Interior of a per capita distribution
18		plan (the "Revenue Allocation Plan") pursuant to the requirements of the Indian
19		Gaming Regulatory Act, 25 U.S.C. § 2710 (b) (3); (2) acceptance by the Legislative
20		Council of a Certification of Eligible Members submitted by the Enrollment Office
21		and based upon receipt of a properly completed and filed Certificate of Eligibility
22	2	Verification for Per Capita Payment for each member; and (3) as to each Minor
23		Eligible Member, establishment of a restricted account at Bank of America for
24		deposit of such member's per capita payment; and
25	WHEREAS,	pursuant to Resolution 97-452, the Legislative Council adopted a Revenue
26		Allocation Plan and caused the Plan to be submitted for approval by the Phoenix
27		Area Office of the Bureau of Indian Affairs in accordance with authority

(Accepting Certification of Eligible Members and Authorizing the Initial Expenditure of Funds for Per Capita Payments under the Initiative) Page 2 of 4 1 delegated to the Area Office by the Secretary of the Interior; and 2 WHEREAS. by letter dated December 18, 1997, the Area Office approved the Revenue 3 Allocation Plan with respect to the Initial Per Capita Distribution and disapproved 4 the Plan with respect to the Biennial Per Capita Payments; and 5 WHEREAS. an agreement with Bank of America has not yet been finalized for the establishment of the restricted accounts which is required as a condition to 6 disbursement of the Initial Per Capita Distribution to such accounts for Minor 7 8 **Eligible Members**; and 9 WHEREAS, pursuant to Resolution Nos. 97-525, 98-010, 98-037, 98-084, 98-128, 98-192, 98-207, 10 98-278, 98-316, 98-360, 98-431, 98-478, 98-505, 99-006, 99-041, 99-081, 99-142, 99-201, 99-312, 99-363, 99-422, 99-478, 99-563, and 99-635 the Legislative Council 11 12 accepted and approved Certifications of Eligible Members for the Initial Per 13 Capita Distribution, and disbursements have been made to such members; and 14 WHEREAS, the Enrollment Office has filed with the Legislative Council a Certification of Eligible Members listing 45 adult members who are eligible for receipt of the 15 Initial Per Capita Distribution; and 16 17 WHEREAS, all conditions under the laws of the United States and the Nation have been satisfied to permit the disbursement of the Initial Per Capita Distribution to the 18 members listed in the Certification of Eligible members. 19 NOW, THEREFORE, BE IT RESOLVED THAT: 20 The Tohono O'odham Legislative Council hereby accepts and approves the 21 Certification of Eligible Members, in the form attached hereto. 22 The Legislative Council authorizes (a) the transfer of the sum of \$90,000.00 23 from the Per Capita Account to the special checking account no. 252-350-324 24 established at Bank of America Arizona (the "Per Capita Checking Account"); 25 and (b) upon the joint signature of the Chairman and Vice Chairman of the 26 Nation, issuance of a check on the Per Capita Checking Account in the 27 amount of (i) \$2,000 to each Eligible Member residing in the United States 28
