

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Granting Compensation for Willard R. Manuel)**

**DEFEATED  
RESOLUTION NO. 2000-010**

1 **WHEREAS, a presentation and request were made by Willard R. Manuel to provide for the**  
2 **administration of justice by reaching findings in his favor and awarding**  
3 **compensation sufficient to compensate him for wrongful termination and place**  
4 **him in the same position as if these wrongs had never occurred.**

5 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby grants**  
6 **Willard R. Manuel compensation for his wrongful termination in the amount of**  
7 **\$33,276.72. This amount represents back pay, with mitigation, for time Willard R.**  
8 **Manuel was forced out of his rightful job and attorney fees.**

10 **The foregoing Resolution was presented to the Tohono O'Odham Legislative Council on the**  
11 **03RD. Day of JANUARY, 2000 at a meeting at which a quorum was present, and by a vote of**  
12 **1,043.95 FOR; 1,121.55 AGAINST; -0- NOT VOTING; and [05] ABSENT, failed to pass because it did**  
13 **not receive a majority of the votes cast as required by Section 2 of Article V of the Constitution**  
14 **of the Tohono O'odham Nation.**
