

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Appointing Camillus Lopez to the Arizona State Museum's American Indian  
Advisory Group)**

**RESOLUTION NO. 2000-014**

1 **WHEREAS, the Arizona State Museum created the American Indian Advisory Group and;**  
2 **WHEREAS, the Advisory Group will provide advice and guidance to the Museum; and**  
3 **WHEREAS, issues that may affect the tribes in the state as they pertain to the Museum's**  
4 **research, collection, preservation and interpretation activities; and**  
5 **WHEREAS, the advisory group will serve as a resource and liaison between the Museum and**  
6 **the Indian peoples of the state; and**  
7 **WHEREAS, one representative is currently on the advisory group, Joseph Joaquin, Cultural**  
8 **Affairs Office; and**  
9 **WHEREAS, the group is expanding to accommodate additional representation; and**  
10 **WHEREAS, two representatives will increase the tribes ability to participate; and**  
11 **WHEREAS, the Cultural Preservation Committee met on December 20, 1999 and elected to**  
12 **appoint Camillus Lopez to serve on the advisory group.**


13 **NOW, THEREFORE BE IT RESOLVED that the Cultural Preservation Committee and the**  
14 **Legislative Council approve the appointment of Camillus Lopez to serve on the**  
15 **Arizona State Museum's American Indian Advisory Group.**

16 **The forgoing Resolution was passed by the Tohono O'odham Legislative Council the 05TH, day**  
17 **of JANUARY, 2000 at a meeting at which a quorum was present with a vote of 1,700.3 FOR; -0-**  
18 **AGAINST; -0- NOT VOTING; and 465.2 [08] ABSENT, pursuant to the powers vested in the Council**  
19 **by Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
20 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
22 **June 18, 1934 (48 Stat. 984).**
