8	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does
9	hereby approve the proposed Budget for FY 1999-00 Title XX-Child Day Care
10	Services in the amount of \$145,988.00, and authorizes the expenditure of funds in
11	accordance with the attached budget as presented by the Tohono O'odham
12	Education Department.
13	BE IT FURTHER RESOLVED that the duration of the Budget will be from July 01, 1999 - June 30,
14	2000.
15	BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono
16	O'odham Nation's officials, to wit: the Chairman and any designated official are
17	hereby authorized to negotiate and execute the contract, provided however, that
18	any amendments affecting the funding levels of this contract shall be submitted for
19	further prior approval by this Council.
