

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Gloria Ramirez to the NCAI Workgroup on Reporting, Accountability
and Auditing)**

RESOLUTION NO. 2000-026

1 **WHEREAS, the National Congress of American Indians (NCAI) at its annual meeting in Palm**
2 **Springs, California held October 4 - 8, 1999 agreed to form four (4) national**
3 **workgroups comprised of tribal leaders to advise and work with the Bureau of**
4 **Indian Affairs (BIA) on four (4) issues affecting Indians nationwide; and**

5 **WHEREAS, NCAI encourages tribal leaders to continue their strong participation and to have**
6 **a voice on important national issues and the Tohono O'odham Nation wishes to do**
7 **the same; and**

8 **WHEREAS, there is a workgroup established by NCAI on Reporting, Accountability and**
9 **Auditing which will advise the BIA on how to develop a consistence reporting**
10 **format which is needed in order to identify unmet need, justify increases and show**
11 **Congress accountability in the use of funds; and**

12 **WHEREAS, the Chairman of the Legislative Council in consultation with the Chairman of the**
13 **Nation, recommends Gloria Ramirez, Member of the Budget and Finance**
14 **Committee be appointed to serve on the national workgroup representing the**
15 **Tohono O'odham Nation.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
17 **appoint Gloria Ramirez, Member of the Tohono O'odham Nation Legislative**
18 **Council Budget and Finance Committee as the Tohono O'odham Nation's**
19 **representative on the NCAI Reporting, Accountability and Auditing Workgroup.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH,**
22 **day of JANUARY, 2000 at a meeting at which a quorum was present with a vote of 2,079.6 FOR;**
23 **-0- AGAINST; 85.9 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council**
24 **by Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
25 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
27 **June 18, 1934 (48 Stat. 984).**
