

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appointing Kenneth Williams to the NCAI Workgroup on FY 2001/2002 Budget
and Distribution Plan)**

RESOLUTION NO. 2000-027

1 **WHEREAS, the National Congress of American Indians (NCAI) at its annual meeting in Palm**
2 **Springs, California held October 4 - 8, 1999 agreed to form four (4) national**
3 **workgroups comprised of tribal leaders to advise and work with the Bureau of**
4 **Indian Affairs (BIA) on four (4) issues affecting Indians nationwide; and**

5 **WHEREAS, NCAI encourages tribal leaders to continue their strong participation and to have**
6 **a voice on important national issues and the Tohono O'odham Nation wishes to do**
7 **the same; and**

8 **WHEREAS, there is a workgroup established by NCAI on FY 2001/2002 Budget and Distribution**
9 **Plan which will work with the existing BIA/Tribal Task Force on the BIA budget to**
10 **ensure that the changes work to the benefit of tribes, that increases will be**
11 **distributed equitably to tribes, and in gaining Congressional support once a**
12 **satisfactory budget has been developed; and**

13 **WHEREAS, the Tohono O'odham Legislative Council recommends that Kenneth Williams,**
14 **Chairman of the Appropriations Committee be appointed to serve on the national**
15 **workgroup representing the Tohono O'odham Nation.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
17 **appoint Kenneth Williams, Chairman of the Tohono O'odham Nation Legislative**
18 **Council Appropriations Committee as the Tohono O'odham Nation's**
19 **representative on the NCAI FY 2001/2002 Budget and Distribution Plan workgroup.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH,**
21 **day of JANUARY, 2000 at a meeting at which a quorum was present with a vote of 1,506.15 FOR;**
22 **436.75 AGAINST; 222.6 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the**
23 **Council by Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted**
24 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**
25 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
26 **Act of June 18, 1934 (48 Stat. 984).**
