2 **above named applicant is eligible for enrollment as a member of the Tohono**
3 **O'odham Nation under Section I(a) or (b) of Article II of the Constitution of the**
4 **Tohono O'odham Nation, and that their application is approved, as herein above**
5 **indicated.**

6 **BE IT FURTHER RESOLVED** that the Chairman and other appropriate
7 **officers of the Tohono O'odham Nation reduce this final determination in**
8 **writing regarding each of the foregoing applications for enrollment in**
9 **accordance with Section 1(a) of Article XIII of the Enrollment Ordinance; give**
10 **notice of this Council's determination in accordance with Section 2 of Article**
11 **XIII of the Enrollment Ordinance; and place the names of each applicant upon**
12 **the membership roll of the Tohono O'odham Nation in accordance with Sections**
13 **2 and 3 of Article X of the Enrollment Ordinance.**

14 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 07TH.**
15 **Day of FEBRUARY, 2000 at a meeting at which a quorum was present with a vote of 2,101.45**
16 **FOR; -0- AGAINST; 64.05 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the**
17 **Council by Section 1 of Article II and Section 1(h) of Article VI of the Constitution of the Tohono**
18 **O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved**
19 **by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**
20 **pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
