1 **WHEREAS, Lena M. Listo was nominated to participate in the 2000 National Youth Leadership**
2 **Forum on Medicine; and**

3 **WHEREAS, the 2000 National Youth Leadership Forum on Medicine recognizes students for**
4 **their interest and academic excellence, leadership potential and their intent to**
5 **pursue a career in medicine; and**

6 **WHEREAS, the 2000 National Youth Leadership Forum on Medicine is dedicated to helping**
7 **prepare our nation's most promising future physicians for the opportunities and**
8 **responsibilities which lie ahead; and**

9 **WHEREAS, Lena is a member of Gu Achi District and resides in Florence with her mother; and**

10 **WHEREAS, on January 08, 2000 the Gu Achi District Council did vote to provide financial**
11 **assistance to Lena in the amount of \$325.00; and**

12 **WHEREAS, the Budget & Finance Committee met on January 14, 2000 and voted to support the**
13 **request; and**

14 **WHEREAS, the Investment Committee met on February 03, 2000 recommends the funding be**
15 **taken from IC-007 account; and**

16 **WHEREAS, the financial assistance will cover the following:**

17	1. Forum cost of	\$1,785.00
18	2. Clothing Costs	\$400.00
19	3. Air fare & Incidentals	<u>\$815.00</u>
20	Total of	\$3,000.00

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
22 **supports and approves the financial assistance request to Lena M. Listo in the**
23 **amount of \$3,000.00 to be appropriated from IC-007 Investment Account.**

25 **day of FEBRUARY, 2000 at a meeting at which a quorum was present with a vote of 1,879.0 FOR;**
26 **-0- AGAINST; -0- NOT VOTING; and 286.5 [06] ABSENT, pursuant to the powers vested in the**
27 **Council by Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation,**
28 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**
29 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
30 **16 of the Act of June 18, 1934 (48 Stat. 984).**




