7	WHEREAS, Chukut Kuk District Council did approve to amend the supplemental budget with
8	an addition of \$110,310.83. The additional funds will be utilized to complete the
9	approved housing repair projects; and
10	WHEREAS, Chukut Kuk District does have sufficient funds to cover the amendment to the
11	supplemental budget.
12	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby
13	approves the amendment to Chukut Kuk District Supplemental Budget in the
14	amount of \$110,310.83 which is to come from Chukut Kuk District's investment
15	accounts, bringing the total Supplemental Budget to \$610,310.83.
16	BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council authorizes a
17	continuing resolution for the Chukut Kuk District Supplemental Budget for
18	calendar year January 01 - December 31, 2000.
