**RESOLUTION NO. 2000-045** 

1	WHEREAS, the Nation has been awarded a grant from the Administration for Native Americans
2	in the amount of \$131,901; and
3	WHEREAS, upon notice of the grant award and call for negotiation, the Nation, through the
4	Executive Branch and the Planning Office negotiated with the ANA and committed
5	via letter to the ANA \$52,923, roughly half of the original commitment as submitted
6	in the grant application; and
7	WHEREAS, this amount is required to accommodate the shortfall in funds actually awarded
8	by the ANA to the Nation; and
9	WHEREAS, the cost of this leverage shall come from the Nation's IC-007 Account.
10	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Nation does allocate and commit
11	\$52,923.00 from the Nation's IC-007 Account to the cost of the Land Use Plan as
12	proposed under the final ANA grant award and negotiation.
13	BE IT FURTHER RESOLVED that the Chairman of this Nation is authorized to execute the grant
14	and/or any other documents reasonably necessary for implementation of the ANA
15	grant award funds and to expend funds when received.
