6		enterprises, including the Tohono O'odham Gaming Authority, in connection with						
7		the establishment of 401(k) pension plans; and						
8		the Attorney General recommends engaging the Attorney to provide legal advice						
9		and representation in connection with the adoption and implementation of a						
10		401(k) pension plan on the terms set forth in the Attorney Contract attached hereto;

12	WHEREAS,	the Domestic Affairs Committee and Human Resources Development Committee						
13		recommend approval by the Legislative Council of the Attorney Contract.

16		Robert R. Yoder in the amount of \$15,000.00 for the fiscal period from January

19		operating budget of the Office of Attorney General.						
20		3. The Chairman of the Nation is authorized and directed to execute the Attorney
