Develop the Community Street Naming Project)**

RESOLUTION NO. 2000-048

1 **WHEREAS, Section 1032, of PL 102-240, 105 Stat. 1974, the Intermodal Surface Transportation**
2 **Efficiency Act (ISTEA) of 1991 provides that up to 2 percent of funds made available**
3 **for Indian Reservation Roads for each fiscal year shall be allocated to those Indian**
4 **Tribal governments applying for transportation planning pursuant to the Indian**
5 **Self-Determination and Education Assistance Act; and**

6 **WHEREAS, the Planning Department through its Transportation Program has been working**
7 **with communities and Districts on developing street naming plans; and**

8 **WHEREAS, the Legislative Council of the Tohono O'odham Nation wishes to ensure full**
9 **participation of the Districts and their members in the development of the Tohono**
10 **O'odham Nation Transportation Planning Study; and**

11 **WHEREAS, the Legislative Council of the Tohono O'odham Nation wishes to continue the**
12 **Transportation Planning Study by developing community master street plan maps;**
13 **and**

14 **WHEREAS, this project will facilitate the full participation of the Tribe in planning of**
15 **Transportation Facilities for the Tohono O'odham Nation.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council of the Tohono O'odham Nation**
17 **authorizes the AFA 2% funds to be carried forward into FY 2000 as per the attached**
18 **budget proposed by the Planning Department.**

19 **BE IT FURTHER RESOLVED that the Chairman of the Nation is authorized to execute the**
20 **attached budget.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH,**
22 **day of FEBRUARY, 2000 at a meeting at which a quorum was present with a vote of 2,060.7 FOR;**
23 **-0- AGAINST; 104.8 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council**
24 **by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
25 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
27 **June 18, 1934 (48 Stat. 984).**
