6	or before December 30, 1999; and
7	WHEREAS, the Tohono O'odham Police Department is requesting an appropriation of
8	\$83,658.30 from the IC-007 account; and
9	WHEREAS, these funds are restricted for the completion of the projects as listed in the
10	attached budget.
11	NOW, THEREFORE, BE IT RESOLVED that the appropriation of \$83,658.30 is hereby approved
12	as submitted and is authorized to be expended accordingly.
13	BE IT FURTHER RESOLVED that these dollars would be funded out of the IC-007 account.
