**RESOLUTION NO. 2000-059**

1 **WHEREAS, pursuant to Resolution No. 99-574, a Computer Network Expansion Three (3) year**  
2 **proposal was submitted and granted by the Health Resources and Service**  
3 **Administration (HRSA); and**

4 **WHEREAS, a budget modification is submitted for review and approval by the Department of**  
5 **Human Services to utilize federal carry-over funds from the FY-99 Budget; and**

6 **WHEREAS, the unused federal funds will be dispersed into newly added line items and existing**  
7 **line items for FY-2000 budget.**

8 **NOW, THEREFORE, BE IT RESOLVED BY THE TOHONO O'ODHAM LEGISLATIVE COUNCIL:**

9           **1. It hereby approves and authorizes expenditures of funds in accordance with**  
10           **the attached budget modification number three if approved by the HRSA to**  
11           **carry forward the funds into year three, submitted by the Department of**  
12           **Human Services.**

13           **2. The Tohono O'odham Nation officials, to wit: the Chairman and Vice Chairman**  
14           **and any designated official are hereby authorized to negotiate and execute the**  
15           **contract.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH**  
17 **day of FEBRUARY, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR;**  
18 **-0- AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**  
19 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
20 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
22 **June 18, 1934 (48 Stat. 984).**
