

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval of FY 2000 Department of Human Services/Division of Community  
Health Services - Home Health Third Party Revenue Budget Amendment #1)**

**RESOLUTION NO. 2000-060**

1 **WHEREAS, the Tohono O'odham Nation is presently developing a Home Health Agency under**  
2 **IHS Grant #IHS002103-02 with the Indian Health Services; and**

3 **WHEREAS, the Legislative Council, through Resolution No. 98-501, established a new Special**  
4 **Revenue Fund and budget for additional Personnel and Operational expenditures**  
5 **using third party revenues; and**

6 **WHEREAS, the Legislative Council, through Resolution No. 99-438, established the FY 2000**  
7 **Home Health third party revenue budget; and**

8 **WHEREAS, the Tohono O'odham Nation's Human Resources has approved a reclassification**  
9 **of the Home Health Nurse Supervisor position; and**

10 **WHEREAS, a budget amendment containing two additional line items is submitted for review**  
11 **to continue providing home health services.**

12 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 13 **1. It hereby approves the Home Health third party revenue budget amendment #1**  
14 **as proposed.**
- 15 **2. The Tohono O'odham Nation Officials, to wit: the Chairman and Vice Chairman**  
16 **and any designated Official are hereby authorized to negotiate and execute**  
17 **contracts and expend funds when received.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH.**  
19 **day of FEBRUARY, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR;**  
20 **-0- AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
21 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
22 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
23 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
24 **June 18, 1934 (48 Stat. 984).**
