

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Department of Labor-Title IVA FY 1999 Modification #2)**

RESOLUTION NO. 2000-063

1 **WHEREAS, the Tohono O'odham Nation JTPA/NEW Program has been funded through the**
2 **Department of Labor, Title IVA FY 1999 in the original amount of \$459,405.00; and**
3 **WHEREAS, carry over amounts in the amount of \$133,296.00 have been identified through**
4 **internal accounting and the Department of Labor; identified in Mod. #1; and**
5 **WHEREAS, carry over amounts in the amount of \$46,246.00 have been identified through**
6 **internal accounting and the Department of Labor; identified in Mod. #2; and**
7 **WHEREAS, the Tohono O'odham Nation, in conjunction with the Department of Labor will cost**
8 **share any and all reasonable, allowable and allocable charges; and**
9 **WHEREAS, the Job Training plan works for the Nation with referrals, case management, pre-**
10 **employment training, job creation, Support Services, GED services and Adult Basic**
11 **Education.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
13 **approve the Department of Labor, Title IVA FY 1999 Budget Modification in the**
14 **amount of \$46,246.00.**

15 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
16 **Nation's Officials, to wit; the Chairman and any designated official are hereby**
17 **authorized to negotiate and execute the contract, provided however, that any**
18 **amendment affecting the funding or funding levels of this contract shall be**
19 **submitted for further prior approval by this Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH day**
21 **of FEBRUARY, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**
22 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
23 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
24 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
26 **18, 1934 (48 Stat. 984).**
