

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Gu Achi District FY-2000 Budget Amendment)

RESOLUTION NO. 2000-064

1 WHEREAS, the Gu Achi District Council has reviewed and considered amending the balance of
2 the FY-99 Supplement budget to the current FY-2000 budget; and

3 WHEREAS, the Gu Achi District FY-2000 budget was \$782,990.72 and it will be amended by an
4 increase of \$198,497.96, totaling a new budget amount of \$981,488.68; and

5 WHEREAS, the Gu Achi District does have sufficient funds to cover the amendment; and

6 WHEREAS, the Tohono O'odham Legislative Council has reviewed the proposed budget
7 amendment and approves the same.

8 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
9 approves the Gu Achi District Council budget amendment in accordance with the
10 attached budget.

11 BE IT FURTHER RESOLVED that the balance remaining in the FY 1999 Supplement budget,
12 \$198,497.96, is hereby carried over into the Gu Achi District FY 2000 Budget, for a
13 total base budget of \$981,488.68.

14 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH, day
15 of FEBRUARY, 2000 at a meeting at which a quorum was present with a vote of 1,810.7 FOR; 354.8
16 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by
17 Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the
18 Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
19 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
20 18, 1934 (48 Stat. 984).


