

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Confirmation of the Appointment of Ms. Theoria "Ora" Campillo as the  
Executive Director of Gaming)**

RESOLUTION NO. 2000-065

1 WHEREAS, the Constitution of the Tohono O'odham Nation provides that governmental  
2 department directors be appointed by the Chairman of the Nation and to be  
3 confirmed by the Tohono O'odham Council; and

4 WHEREAS, Ms. Theoria Campillo is qualified to assume the position of Director of Gaming;  
5 and

6 WHEREAS, Ms. Theoria Campillo has accepted the appointment when offered by the Chairman  
7 of the Nation.

8 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that the  
9 appointment of Ms. Theoria Campillo is hereby confirmed.

10 BE IT FURTHER RESOLVED that Ms. Theoria Campillo shall serve at the pleasure of the  
11 Chairman of the Nation.

12 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH,  
13 day of FEBRUARY, 2000 at a meeting at which a quorum was present with a vote of 2,037,4 FOR;  
14 64,05 AGAINST; 64,05 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the  
15 Council by Section 1 (b) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted  
16 by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy  
17 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the  
18 Act of June 18, 1934 (48 Stat. 984).
