**(Approving an Intergovernmental Agreement (IGA) between Bureau of Reclamation**  
**(BOR) and the Tohono O'odham Nation for Aerial Photographic and Community**  
**Street Mapping Services)**

**RESOLUTION NO. 2000-070**

1 **WHEREAS, the Tohono O'odham Nation is developing its Transportation Program, under the**  
2 **Planning Department, through a PL-638 Annual Funding Agreement with the BIA;**  
3 **and**

4 **WHEREAS, the transportation workplan provides for the development of community street**  
5 **naming and identification; and**

6 **WHEREAS, the Bureau of Reclamation has the expertise and resources for the production of**  
7 **maps from aerial photography; and**

8 **WHEREAS, the Transportation Program has an approved budget which includes funds for aerial**  
9 **photographic mapping services; and**

10 **WHEREAS, representatives of the Executive Branch and the BOR have drafted mutually agreed**  
11 **upon Inter-Governmental Agreement for specific aerial photographic mapping**  
12 **services in the amount of \$12,179.00 to be administered by the Planning Department.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Chairman of the Nation is authorized to execute the**  
14 **attached Intergovernmental Agreement with the Bureau of Reclamation for the**  
15 **purpose of acquiring certain mapping services.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH day**  
17 **of FEBRUARY, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**  
18 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
19 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
20 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
22 **18, 1934 (48 Stat. 984).**
