6	to secure the legal services not available through the Office of Attorney General for
7	the foregoing reasons, a copy of which is attached hereto; and
8	WHEREAS, the approved budget of the Legislative Council for Fiscal Year 2000 has available
9	funding sufficient to pay all fees and expenses under the Attorney Contract; and
10	WHEREAS, the Domestic Affairs and Budget and Finance Committees did review the Contract
11	and recommends for approval.
12	NOW, THEREFORE, BE IT RESOLVED THAT:

13	1. The Attorney Contract with the law firm of Nancy Robinette, P.C. is hereby

17	2. All fees and expenses incurred under the Attorney Contract shall be payable
18	from the approved budget of the Legislative Council for Fiscal Year 2000.

20	authorized and directed to execute the Attorney Contract.
