

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 2001 Appropriations Priority Listing)**

RESOLUTION NO. 2000-078

1 **WHEREAS, the Tohono O'odham Legislative Council establishes priorities annually for**
2 **consideration by Congress during its Appropriations Hearings; and**

3 **WHEREAS, the Legislative Appropriations Committee recommends the establishment of top**
4 **priorities based on the needs and type of services provided to the people; and**

5 **WHEREAS, the Legislative Appropriations Committee has established four areas as the top**
6 **priorities for FY 2001 for consideration by Congress during the appropriations**
7 **process.**

8 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
9 **adopts the following appropriations priority ranking for FY 2001 and respectfully**
10 **urges Congress to appropriate such funds as necessary to increase the four areas to**
11 **an exemplary level of funding:**

20 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
21 **18, 1934 (48 Stat. 984).**
