

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting Certification of Eligible Members and Authorizing the Initial
Expenditure of Funds for Per Capita Payments under the Initiative)

RESOLUTION NO. 2000-085

1 **WHEREAS, on June 28, 1997 the voters of the Tohono O'odham Nation (the "Nation") approved**
2 **Initiative No. IN-01-97 (the "Initiative"); and**

3 **WHEREAS, the Initiative authorized funding from Gaming Revenues for several measures,**
4 **including a one-time per capita distribution of \$2,000 to each member of the Nation**
5 **enrolled on June 28, 1997 (the "Initial Per Capita Distribution"); and**

6 **WHEREAS, pursuant to Resolution 97-451, the Legislative Council adopted an Initiative Funding**
7 **and Implementation Plan (the "FIP") which authorized the establishment of set-**
8 **aside accounts for the Initial Per Capita Distribution and other Initiative measures,**
9 **and set certain conditions on the expenditure of funds from such accounts; and**

10 **WHEREAS, by Resolution 97-478, the Legislative Council approved the transfer of funds from**
11 **the Desert Diamond Savings Account to certain designated set-aside accounts**
12 **established at Bank of America Arizona, including the sum of \$41.5 million to set-**
13 **aside account no. 3030425-1067524 for the Initial Per Capita Distribution (the "Per**
14 **Capita Account"); and**

15 **WHEREAS, three of the conditions to expenditure of the Per Capita Account specified in the FIP**
16 **are (1) approval by the Secretary of the Interior of a per capita distribution plan (the**
17 **"Revenue Allocation Plan") pursuant to the requirements of the Indian Gaming**
18 **Regulatory Act, 25 U.S.C. § 2710 (b) (3); (2) acceptance by the Legislative Council of a**
19 **Certification of Eligible Members submitted by the Enrollment Office and based**
20 **upon receipt of a properly completed and filed Certificate of Eligibility Verification**
21 **for Per Capita Payment for each member; and (3) as to each Minor Eligible Member,**
22 **establishment of a restricted account at Bank of America for deposit of such**
23 **member's per capita payment; and**

24 **WHEREAS, pursuant to Resolution 97-452, the Legislative Council adopted a Revenue**
25 **Allocation Plan and caused the Plan to be submitted for approval by the Phoenix**
26 **Area Office of the Bureau of Indian Affairs in accordance with authority**
27 **delegated to the Area Office by the Secretary of the Interior; and**

1 **WHEREAS, by letter dated December 18, 1997, the Area Office approved the Revenue Allocation**
2 **Plan with respect to the Initial Per Capita Distribution and disapproved the Plan**
3 **with respect to the Biennial Per Capita Payments; and**

4 **WHEREAS, an agreement with Bank of America has not yet been finalized for the establishment**
5 **of the restricted accounts which is required as a condition to disbursement of the**
6 **Initial Per Capita Distribution to such accounts for Minor Eligible Members; and**

7 **WHEREAS, pursuant to Resolution Nos.97-525, 98-010, 98-037, 98-084, 98-128, 98-192, 98-207,**
8 **98-278, 98-316, 98-360, 98-431, 98-478, 98-505, 99-006, 99-041, 99-081, 99-142, 99-**
9 **201, 99-312, 99-363, 99-422, 99-478, 99-563, 99-635 ,2000-005 and 2000-037 the**
10 **Legislative Council accepted and approved Certifications of Eligible Members for**
11 **the Initial Per Capita Distribution, and disbursements have been made to such**
12 **members; and**

13 **WHEREAS, the Enrollment Office has filed with the Legislative Council a Certification of Eligible**
14 **Members listing 37 adult members who are eligible for receipt of the Initial Per**
15 **Capita Distribution; and**

16 **WHEREAS, all conditions under the laws of the United States and the Nation have been satisfied**
17 **to permit the disbursement of the Initial Per Capita Distribution to the members**
18 **listed in the Certification of Eligible members.**

19 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 20 1. **The Tohono O’odham Legislative Council hereby accepts and approves the**
21 **Certification of Eligible Members, in the form attached hereto.**
- 22 2. **The Legislative Council authorizes (a) the transfer of the sum of \$74,000.00**
23 **from the Per Capita Account to the special checking account no. 252-350-324**
24 **established at Bank of America Arizona (the “Per Capita Checking Account”);**
25 **and (b) upon the joint signature of the Chairman and Vice Chairman of the**
26 **Nation, issuance of a check on the Per Capita Checking Account in the amount**
27 **of (i) \$2,000 to each Eligible Member residing in the United States and listed in**
28 **the attached Certification of Eligible Members and (ii) \$1,400 to each Eligible**

1 Member residing outside the United States and listed in the attached
2 Certification, with the balance of \$600 withheld and remitted to the Internal
3 Revenue Service pursuant to the requirements of federal law.

4 3. The Chairman of the Nation is authorized to execute such other documents as
5 may be necessary to implement this Resolution.

6 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06th, of
7 MARCH 2000 at a meeting at which a quorum was present with a vote of 2,085.5 FOR; 80.0
8 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
9 Section 1(d)(1), (2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted
10 by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
11 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
12 18, 1934 (48 Stat. 984).
