

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Tohono O'odham Tribal Employment Rights Office FY-2000 Budget Amendment No. 1)**

RESOLUTION NO. 2000-088

1 **WHEREAS, the Tohono O'odham Nation has operated the Tribal Employment Rights Office since**
2 **1978 and has successfully met the needs of the Tohono O'odham; and**

3 **WHEREAS, the continued operation of the Tribal Employment Rights Office is essential to**
4 **eradicate employment discrimination within the exterior boundaries of the Tohono**
5 **O'odham Nation; and**

6 **WHEREAS, the Department is in need of establishing line item 752 to purchase two computers**
7 **for staff, and is in need of establishing line item 759 to purchase other equipment to**
8 **serve clientele; and**

9 **WHEREAS, the Tohono O'odham Tribal Employment Rights Office Fiscal Year 2000 Budget**
10 **Amendment No. 1 has been approved by the Office of the Chairman.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Nation Legislative Council that it**
12 **hereby approves the Tohono O'odham Tribal Employment Rights Office Fiscal Year**
13 **2000 Budget Amendment No. 1 in the amount of \$250,945.75.**

14 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH, day**
15 **of MARCH, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**
16 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
17 **Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
18 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
19 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
20 **18, 1934 (48 Stat. 984).**
