WHEREAS, the JTPA/NEW Program provides services for work experience and work related  
activities in compliance with the federal regulations of the Welfare to Work contract;  
and**

**WHEREAS, additional line item Capital Equipment has been added to secure a program vehicle  
to transport students.**

**NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby  
approves the JTPA/NEW FY 1998 Welfare-To-Work Budget Modification #5.**

**BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham  
Nation's officials, to wit: the Chairman and any designated official are hereby  
authorized to negotiate and execute the contract, provided however, that any  
amendment affecting the funding or funding levels of this contract shall be  
submitted for further prior approval by this Council.**

**The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH day  
of MARCH, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-  
AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by  
Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
18, 1934 (48 Stat. 984).**
