

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of Budget Modification #3 FY 1999 Department of Labor Title IVA)**

RESOLUTION NO. 2000-091

1 **WHEREAS, the original budget for the FY 1998 Department of Labor Title IVA was in the amount**
2 **of \$459,405.00; and**

3 **WHEREAS, adjusted final increase of funds from carry over amounts totaling \$179,542.00 for a**
4 **combined FY 1999 amount of \$638,947.00; and**

5 **WHEREAS, the purpose of the Tohono O'odham Nation JTPA/NEW Program is to provide training**
6 **and support services to eligible Native Americans residing on the Tohono O'odham**
7 **Nation; and**

8 **WHEREAS, additional line items were created to expand services for clients.**

9 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
10 **approves the JTPA/NEW Budget Modification #3 for the Department of Labor Title**
11 **IVA FY 1999.**

12 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
13 **Nation's officials, to wit: the Chairman and any designated official are hereby**
14 **authorized to negotiate and execute the contract, provided however, that any**
15 **amendment affecting the funding or funding levels of this contract shall be**
16 **submitted for further prior approval by this Council.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH, day**
18 **of MARCH, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**
19 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
20 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
21 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
22 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
23 **18, 1934 (48 Stat. 984).**
