| 13 |           | execute the Annual Funding Agreement between the Tohono O'odham Nation and            |
| 14 |           | the Secretary of Interior for all services, function, activities and/or programs as   |
| 15 |           | described in the Master Contract at Article 1, subsection 2, Purpose, and the         |
| 16 |           | Annual Funding Agreement for the 2000 fiscal year.                                    |
| 17 |           | 2. In the event that Congress does not appropriate any and/or sufficient funds        |
| 18 |           | commonly known as "Contract Support Funds" for those contracted services,             |
