

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval of Tohono O'odham Gaming Office Amendment No. 1 to FY-2000 Budget)**

**RESOLUTION NO. 2000-103**

1 **WHEREAS, pursuant to Resolution 99-528, the fiscal year 2000 budget of the Tohono O'odham**  
2 **Gaming Office was approved by the Legislative Council as part of the Executive**  
3 **Branch budget for such fiscal year; and**

4 **WHEREAS, due to the essential need and recommendation to replace the motor vehicle; to**  
5 **provide for a computerized/video identification system, to include software for**  
6 **storage and retrieval of applicant information and unanticipated over expenditures**  
7 **in line items, attached hereto is Amendment No. 1 and accompanying**  
8 **documentation and justification of expenses; and**

9 **WHEREAS, a budget amendment adds a line item for Capital Equipment not included in the**  
10 **original Gaming Office budget for fiscal year 2000, requiring approval by the**  
11 **Legislative Council; and**

12 **WHEREAS, the budget adjustments in Amendment No. 1 are funded entirely within amounts in**  
13 **the Gaming Office budget approved by the Legislative Council for fiscal year 2000;**  
14 **and**

15 **WHEREAS, the Executive, Commerce, Budget and Finance Committees recommend approval of**  
16 **Amendment No. 1 by the Legislative Council.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**  
18 **Amendment No. 1 to fiscal year 2000 budget of the Gaming Office, in the form**  
19 **attached hereto.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH, day**  
21 **of MARCH, 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-**  
22 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
23 **Section 1 (d) (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
24 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
26 **18, 1934 (48 Stat. 984).**
