

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Compensation Adjustments of Executive Employees and Authorizing the
Transfer of Funds from Employee Classification Reserve to Appropriate Programs)

RESOLUTION NO. 2000-112

1 **WHEREAS, in adopting the Executive Branch Fiscal Year 2000 budget compensation for certain**
2 **positions were provided for at levels designated as recruit and career ladder; and**

3 **WHEREAS, employees within these positions have attained the necessary qualifications to merit**
4 **full compensation at entry levels for their respective positions; and**

5 **WHEREAS, the adoption of the Executive Branch Fiscal Year 2000 budget only provided a 2.5%**
6 **increase for the Chairman and Vice Chairman of the Nation subject to the additional**
7 **consideration by the Legislative Council of all compensation for the Nation's**
8 **officials; and**

9 **WHEREAS, the Chairman and Vice Chairman of the Nation are eligible for the full adjustment.**


10 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does**
11 **hereby approve and authorize the adjustments of salaries for identified employees**
12 **as provided for in the attached budgets.**

13 **BE IT FURTHER RESOLVED that the salaries of the Chairman and Vice Chairman are hereby**
14 **approved and authorized to be adjusted with an additional 2.5% as provided for in**
15 **the attached budgets.**

16 **BE IT FURTHER RESOLVED that these adjustments are retroactive to October 01, 1999 and that**
17 **the funds for these adjustments are authorized to be transferred from the**
18 **established Employee Classification Reserve to the respective program base budgets**
19 **affected.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH,**
21 **day of MARCH, 2000 at a meeting at which a quorum was present with a vote of 1,835.6 FOR; -0-**
22 **AGAINST; 158.1 NOT VOTING; and 171.8 [08] ABSENT, pursuant to the powers vested in the Council**
23 **by Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted**
24 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
26 **18, 1934 (48 Stat. 984).**
