

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Acceptance of Funds from EPA-TSCA Title IV Tribal Lead Program)**

**RESOLUTION NO. 2000-113**

1 **WHEREAS, the Tohono O'odham Nation applied for and was awarded an EPA grant under TSCA**  
2 **Title IV in the amount of \$49,995.00 to conduct and develop a comprehensive data**  
3 **collection on the incidences of lead poisoning within the Nation; and**  
4 **WHEREAS, the Nation's lead detection activities have been limited to responsive screening and**  
5 **limited data collection; and**  
6 **WHEREAS, the acceptance of these EPA grant funds for a lead program will add to the already**  
7 **existing program currently under the Planning Department.**  
8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
9 **approves the attached budget in the amount of \$49,995.00 for the Lead program, said**  
10 **budget will be in effect from March 1 to September 30, 2000.**  
11 **BE IT FURTHER RESOLVED that the Legislative Council authorizes the Chairman of the Tohono**  
12 **O'odham Nation to execute any contracts or other documents necessary to**  
13 **accomplish the development and implementation of the Lead Program for the**  
14 **Nation.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH,**  
16 **day of MARCH, 2000 at a meeting at which a quorum was present with a vote of 1,993.7 FOR; -0-**  
17 **AGAINST; -0- NOT VOTING; and 171.8 [08] ABSENT, pursuant to the powers vested in the Council**  
18 **by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
19 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
20 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
21 **18, 1934 (48 Stat. 984).**


