RESOLUTION NO. 2000-116

1 **WHEREAS, the Legislative Council of the Tohono O'odham Nation has traditionally supported**
2 **the library activities of the Venito Garcia Library and it accepts the cash donation**
3 **from the Tohono O'odham Gaming Authority for the Library to hold an open house**
4 **for the public and funding agencies.**

5 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
6 **approves the attached budget for the amount of \$700.00 dollars and authorizes the**
7 **expenditure of funds in the amount of \$700.00 dollars in accordance with the**
8 **attached budget presented by the Venito Garcia Library.**

10 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH day**
11 **of MARCH 2000 at a meeting at which a quorum was present with a vote of 2,032.1 FOR; -0-**
12 **AGAINST; -0- NOT VOTING; and 133.4 [05] ABSENT, pursuant to the powers vested in the Council**
13 **by Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
14 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
15 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
16 **18, 1934 (48 Stat. 984).**
