

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Acceptance of Funds from Arizona Humanities Council/Book Bucks Grant for
Venito Garcia Library)**

RESOLUTION NO. 2000-117

1 WHEREAS, the Legislative Council of the Tohono O'odham Nation has traditionally supported
2 the Library Activities of the Venito Garcia Library and it accepts the grant award
3 from the Arizona Humanities Council for the Library to conduct a panel discussion
4 of existing literature in the O'odham language in book form from the viewpoints of
5 the public, teachers, and publishers.

6 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby
7 approve the proposed budget of \$750.00 dollars for said panel discussion and
8 authorizes the expenditure of funds in accordance with the attached budget by the
9 Venito Garcia Library.

10 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH day
11 of MARCH 2000 at a meeting at which a quorum was present with a vote of 2,165.5 FOR; -0-
12 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by
13 Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
14 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
15 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
16 18, 1934 (48 Stat. 984).
