

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorization for FY 2000 Title VI Program Budget Modification #1)**

RESOLUTION NO. 2000-119

1 **WHEREAS, the Tohono O'odham Nation has successfully operated a program for the elderly**
2 **members of the Nation; and**

3 **WHEREAS, funding for the operation of the Elderly Program has been made possible in part by**
4 **Title VI of the Older American's Act of 1965; and**

5 **WHEREAS, the Elderly Program is requesting approval for the FY 2000 Title VI budget**
6 **modification to reflect the grant award amount.**

7 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 8 **1. It hereby approves budget modification #1 for Title VI funding for the Elderly**
9 **Program.**
- 10 **2. The Tohono O'odham Nation officials, to wit: The Chairman and Vice-Chairman**
11 **or designated official are hereby authorized to negotiate and execute the grant,**
12 **provided however, that any amendments affecting the funding or funding levels**
13 **of this grant shall be submitted for further prior approval by this Council.**

14 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH. day**
15 **of MARCH 2000 at a meeting at which a quorum was present with a vote of 2,037.4 FOR; -0-**
16 **AGAINST; 128.1 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
17 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
18 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
19 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
20 **18, 1934 (48 Stat. 984).**


