

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Authorization for FY 2000 Title VI Program Budget Modification #2)**

**RESOLUTION NO. 2000-120**

1 **WHEREAS, the Tohono O'odham Nation has successfully operated a program for the elderly**  
2 **members of the Nation; and**

3 **WHEREAS, funding for the operation of the Elderly Program has been made possible in part by**  
4 **Title VI of the Older American's Act of 1965; and**

5 **WHEREAS, the Elderly Program is requesting approval for the FY 2000 Title VI budget**  
6 **modification.**

7 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council,**

8 **1. That it hereby approves budget modification for Title VI funding for the Elderly**  
9 **Program.**

10 **2. The Tohono O'odham Nation officials, to wit: the Chairman is hereby authorized**  
11 **to negotiate and execute the grant, provided however, that any amendments**  
12 **affecting the funding or funding levels of this contract shall be submitted for**  
13 **further prior approval by this Council.**

14 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup> day**  
15 **of MARCH, 2000 at a meeting at which a quorum was present with a vote of 1,846.7 FOR; -0-**  
16 **AGAINST; 318.8 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
17 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
18 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
19 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
20 **18, 1934 (48 Stat. 984).**






