

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(FY 2000 Indian Health Service Budgets)**

**RESOLUTION NO. 2000-129**

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**  
2 **Indian Health Service; and**

3 **WHEREAS, the Legislative Council has approved Resolution No. 99-343 granting the Executive**  
4 **authorization to submit the Annual Funding Agreement and contract Amendment**  
5 **to the Indian Self Determination Act Master contract and conduct negotiations; and**

6 **WHEREAS, the Executive Branch requires authority to expend funds for the following programs**  
7 **the noted amounts:**

8 **A. Management of Health Programs - \$195,001.00 + \$33,150.00 (Est. IDC)**

9 **B. Community Health Representative Program and the Community Counseling and**  
10 **Relations Services Program - \$1,347,346.00 + \$229,048.00 (Est. IDC)**


11 **C. Psychological Services - \$474,226.00 + \$79,921.79 (Est. IDC)**

12 **D. Alcohol and Substance Abuse Program - \$936,815.00 + \$137,409.51 (Est. IDC)**

13 **NOW, THEREFORE, BE IT RESOLVED that the Executive Branch is authorized to expend funds for**  
14 **the programs listed herein above in the amounts indicated.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH day**  
16 **of MARCH, 2000 at a meeting at which a quorum was present with a vote of 2,032.1 FOR; -0-**  
17 **AGAINST; -0- NOT VOTING; and 133.4 [04] ABSENT, pursuant to the powers vested in the Council**  
18 **by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
19 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
20 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
21 **18, 1934 (48 Stat. 984).**




